The meeting was called to order at 7:00 p.m. in the Sweetland Hall by the Rector. The vestry went outside on the lawn to focus and Kinman then offered the opening prayer.

Visitor Welcome - Kinman welcomed the visitors and asked them to introduce themselves.

## BUSINESS ITEMS

## Approval of the Consent Agenda

, Report of the Clerk and Committee Reports: It was moved, seconded and the vestry unanimously approved the consent agenda including the minutes and committee reports as received.

## Report of the Treasurer

Albarano reported that the financials were a little down in April but we are doing fine with $38 \%$ of budget collected. The building usage has been good within $\$ 6 \mathrm{k}$ of annual budget. We need parishioners to keep up with their pledges during the summer months.

## Fall Giving Campaign

Knowles reported that a Giving Advisory Group has been formed. The mission, purpose, responsibilities and members of the advisory have been developed and distributed to the vestry. The role of the vestry is generosity in giving and communicating to the parish why we give. She distributed the 2020 Fall Campaign Timeline. The campaign begins in October. There will be follow-ups in November and a silent December. Presentation Sunday will be January 26. The renewed Legacy Wall will be a $10^{\prime} \times 10^{\prime}$ watercolor high resolution print behind 5 panels with names. Dedication of the wall will be on Thursday, September 5.

## IMMIGRANT SANCTUARY DISCUSSION

Kinman reviewed the values of All Saints. Four working groups have formed to support our values and provide resources as a sanctuary church. Following discussion it was moved and seconded that the vestry support the action of the Rector to declare All Saints a sanctuary church. The vestry unanimously supported this action.

## GOVERANCE DOCUMENT

Kinman reviewed the governance document, explaining that All Saints Church is bound by the constitution and canons of the Episcopal Church. The document provides support and accountability; it defines roles and responsibilities. The vestry reviewed the document and asked questions. Kinman asked the vestry for any thoughts and comments.

## FOUR FOUNDTIONAL GOALS

## Determining our Values, Mission and Vision

Jackson reviewed the work done on the values and the many meetings held to get input from the parishioners. The values were then read in English and Spanish. It was moved, seconded and the vestry unanimously approved the values of All Saints Church. Many thanks to Tony Jackson and the committee for their work. On August 27 there will be a called vestry meeting to begin the process of setting the vision. They asked the vestry to think of 3-5 tangible ways to engage the values. What is the ASC vision?

## Address Serious Staffing Capacity Issues

Kinman reported that every employee job description is being developed. They are working in groups and using a common template. There will be work on the mutual ministry review and salary structure. They are looking for just wages, salaries and benefits. The search committee is working on the two associate rector positions. Interviews are being scheduled on site in August.

## Provide Safe, Welcoming Space for Ministry

Schield introduced Blaine Cavena who is on the PACES External Review Board, which gives feedback to the core team about the work and asks questions. Work is currently done that was approved by the vestry. Tours are continuing. They would like the vestry to encourage their groups to attend one of the tours.

## Inspire Congregational Leadership \& Development

Naecker reported that the Small Group Steering Committee is working on a structure and training for facilitators. There is work with the coordinators to make consistent format. They are working to build lasting connections and promoting leadership. There have been around 300 small groups thus far this year. There will be a series of 3 listening sessions in July.

## PLAYGROUND PROPOSAL

Hartman shared the CYF Committee proposal for funds for playground equipment and installation. It was moved and seconded and following discussion the vestry unanimously approved spending up to $\$ 152,000$ from Capital Campaign Funds for immediate use to order and install playground equipment in the north yard. This has been reviewed by CYF, PACES, Capital Campaign Finance, and the vestry Finance Committee and unanimously passed by each committee. Thanks to Christine Hartman, Kelly O'Phelan, Scott England and all those involved in moving this along. The plan is to have it installed by September 1 for CYF Sunday.
