The meeting was called to order at 6:01 p.m. by Sr. Warden Juan Mejia using Zoom Webinar. Feregrino focused on what it means to walk with the revolutionary Jesus. He focused on the prayer steps of Lectio Divina. He read a passage from Isaiah 55 8-9 for meditation, prayer and reflection. He concluded with a prayer from Psalms 139 23.

Mejia thanked the visitors who were online for the webinar.

The vestry read the mission statement of All Saints Church aloud together.

BUSINESS ITEMS

Approval of the Consent Agenda

Report of the Clerk and Committee Reports: It was moved, seconded and the vestry unanimously approved the consent agenda including the minutes and committee reports as received.

Report of the Treasurer

Albarano reported that we have collected 61% of our annual budget which is in line with past years. We are ahead on the income side because of prepaid pledges. We have savings in personnel due to unfilled positions. We will be working with finance to prepare for the end of the year.

Finance Committee Report

Hudson reported that we are looking at year-end projections. The investment subcommittee is working on updating the investment policy, which has not been updated since 2002.

Giving Report/Pledging

Knowles reported there is nothing new since last report. They are analyzing the information for budget projections and items like open plate will be different since we have been virtual since March. The 2021 campaign will kick off on October 18. Letters will be going out tomorrow and the website will be up this week for 2021 pledges. The goal will be \$3 million. Thank you to the vestry members who have generously completed their 2021 pledge.

Mejia announced that the courts will be fully operational on Friday so parking income will begin to come in again.

REPORTS

PACES

Mejia introduced Phil Naecker and Blaine Cavena to give an update report on PACES. Cavena showed a slide presentation reviewing a recap, challenges, vestry's role, and progress made. He reviewed the process on the 10 possible projects. The work was presented to the vestry in September 2019 and then to the parish from October to March. A couple of projects have been moved forward to refinement. Naecker shared that some new people have volunteered to work on the Design Plan Review Team. The team includes Eric Brossy de Dios, Hans Herst, Jerry Higgins, Chris Runco, Lonnie Shields, and Phil Naecker. They presented two in-depth projects including upgrading the old Rectory/offices into new meeting space and replacing Scott Hall with space for CYF classrooms, office spaces and a possible kitchen. Both included major seismic upgrades to bring the buildings up to code. The study included cost estimates to project costs. They then opened the presentation to questions and discussion from the vestry. High commendations from the vestry went to the PACES Committee for the work done. Mejia expressed thanks to Naecker, Cavena, and Shields for their work.

Safe Haven

Howard reported that with the installation of the lockers, progress has been made on full implementation of the program. Last week we received a letter of complaint from the Maryland Homeowners Association. Howard responded to the letter, addressing their concerns.

The city planning department also sent a letter of concern. They would require a minor conditional use permit as a temporary shelter. They wanted to ensure that the activity would be restricted on the ASC campus. We are exploring what this permit entails.

Howard has met with the Safe Haven community and discussed the neighbor's concerns. Vestry discussion followed.

Children, Youth & Families Continuity

Esseln reported that the CYF Continuity Team has been working on communication and care of our youth during the transition. They are planning to have another youth town hall meeting.

The youth are planning a goodbye for Jeremy Langill, including a drive-by at Boston Court and a Zoom goodbye meeting just for youth and Jeremy.

They are working on video to connect more youth. Commendations went to Esseln and Graham for their leadership.

CRT Report

Hartman reported that CRT had a session that focused on the volunteers who are providing calls and notes to our community. This is called Caring for the Carers and is headed by Staci Kennelly. The Zoom meeting was well received and they are planning another for October before the election for some spiritual support.

Diaz is working on a financial support workshop. They are working on side-by-side companions and reconnecting with those who the team spoke with in March.

The cards and notes have been well received by the hospitals. Support of healthcare workers and hospitals will continue.

Congregational Development

Diaz appreciated the wonderful job done by the Homecoming Committee for their digital celebration. Special appreciation goes to Larry Gonzalez, Jim Jansen, Jessica Murray and Kyle Johnson for the Share Your Joy video. Celebration of Ministries was also a success. Thanks to Michael Paul Wong who was a wonderful host and Walter Little who ran the Behind the scenes Kahoots game.

Small groups are rolling out. Getting Connected begins October 9 and we have at least 20 participants. LGBTQ+ has a new talk series called "The Talk". This month will be an educational campaign series on LGBTQ+ to speak of the acronym.

Website redesign is progressing. Sarah Phillips and Jason Luckett continue working on this committee.

Welcome cards are coming in and they are being responded to by volunteers. They send a message to encourage the newcomers to come to the Welcome Café and the Getting Connected class.

JR. WARDEN REPORT

Thomas reported that there will be a 24-hour Zoom vigil during the election from noon to noon on November 3 and 4. Prayer, meditation, small discussion and music will be offered. Volunteers who want to take an hour of the vigil are welcome to contact Jim Albarano.

There will be a group walking from All Saints to the ballot drop box at City Hall on October 17 at 1 p.m.

SR. WARDEN REPORT

We will be streaming from the sanctuary on October 18 and on All Saints Day on November 1. We may also stream for Advent. It was wonderful to be back in the sanctuary on Homecoming.
