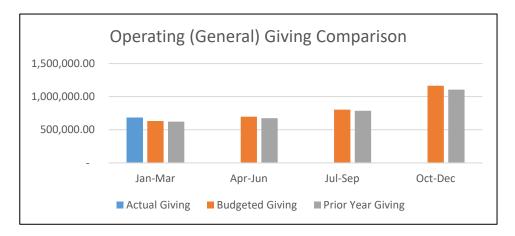

#### **NOTES & HIGHLIGHTS**

The end of a quarter is a good time to evaluate financial results and what those results may say about the future. The operating results for the quarter through March generally indicates stability within the confines of a deficit budget. That is, operating income and expenses are on track and does not indicate a substantial negative impact from the fires in January. Designated and restricted funds balance has increased due to onboarding the Foster Care Project and receipt of significant special gifts to support fire recovery efforts. As of March 31st, the recent stock market uncertainty may have depressed net earnings but had not yet resulted in losses.

A Pledge income exceeded budget in March by \$75k which puts us ahead of year-to-date budget as well. The value in the first quarter of such results is to build confidence in the reliability of the budget and in the congregation's support of recent operational changes. We have also not yet had to make cash draws from funds held in high-interest money market funds, so Investment Income continues to exceed expectations.

Operating Giving in total (pledge, plate, and other operating contributions) is basically on track, as reflected in the graph below. The graph compares actual giving in 2025 to budget and to 2024 actuals (not including extraordinary gifts).



B The net operating loss for March was \$47,310 which is almost \$60k better than budget and serves to increase the favorable year-to-date budget variance as well. In total, operating income was \$91k more than budgeted (mostly attributable to pledges as noted in "A" above). The excess income was partially offset by higher than budgeted Personnel Expenses. As noted last month, the operating budget spreads the cash impact of personnel changes through June. In actuality, the majority of such expenses were incurred in March as lump sum separation payments were made. By summer we expect to see year-to-date Personnel expenses in better alignment with budget.
