MEASURE H - **All Saints Church Endorses**

Pasadena Charter Amendment Initiative Petition Measure
Imposing Rent Control

The purpose of this Amendment is to promote neighborhood and community stability, healthy housing, and affordability for renters in Pasadena by regulating excessive rent increases and arbitrary evictions to the maximum extent permitted under California law, while ensuring Landlords a fair return on their investment and guaranteeing fair protections for renters, homeowners, and businesses.

MEASURE L

Pasadena Public Library Services Continuation Measure

An Ordinance of the City of Pasadena Extending and Amending Chapter 4.109 of Title 4 of the Pasadena Municipal Code, The Library Special Tax, subject to the approval of two-thirds of the votes cast by voters voting upon the proposal within the City of Pasadena.

MEASURE PCC - **All Saints Church Endorses**

Pasadena City College \$565,000,000 bond

Measure PCC would fund projects and add to the school's budget, compensating for what the state does not provide beyond operational costs for projects like additional student services, expanded job training, low-cost higher education, and upgrades to classrooms, labs, and technological equipment. Other aspects of the measure include building maintenance, and expansion to additional satellite campuses to further the reach of Pasadena City College.
