#### **NOTES & HIGHLIGHTS**

- A One positive impact of getting caught up in financial reporting is that we can now invest time in improving consistency and clarity. To that end, we have made a some fund balance reclassifications and corrections (e.g.; Rector's Consultant Fund, Rector's Discretionary, and Webb/Learned Trust Fund). We also were able to set up the new Centennial Fund.
- B There are two projects that impact the financial reporting that are still a work in progress. First, the Buildings & Grounds Committee has provided contracts and worksheets that will allow us to reconcile the major improvement project and move the remaining balance in what was approved by Vestry into its own fund (more on that next month). Second, we continue to work with staff to improve policies and procedures around use of credit cards. To that end, approximately \$60k in credit card transactions were recorded in September that were applicable to prior months. To the extent that the accounting office was not provided with receipts, the expenses have been recorded to the staff person's "business expense" account (in the Personnel department). October is the first month of a new procedure implemented after having all cardholders sign a credit cardholder agreement. We believe the new procedures will provide for more efficiency and better spending controls.
- C In September, the church's balance in cash accounts decreased by approximately \$500k, primarily due to major draws from Quasi-Endowment for the major Buildings & Grounds projects. We have begun discussions with the Investment Committee to address cash needs in the next 12-18 months as well as rebalancing cash and investments for compliance with the Investment Policy.
- P Year-to-date operating results (deficit of \$249k) remains largely due to pledge collections that are less than budget and no filming income. Current projections we expect to end the year with a loss of between \$250k and \$350k.
