## ALL SAINTS CHURCH Financial Statements November 30, 2023

#### **NOTES & HIGHLIGHTS**

- A November pledge income was \$107,999 more than budget which positively impacts our year-end projections. The remainder of November income and expensess are generally in line with budget. Interestingly, November 2022 was reported as a very low income month; however, the giving office was in transition at that time and so the dating of some gifts may have been impacted thereby reducing the usefulness of the 2022 comparative data.
- B The year-to-date operating net loss (through November) is \$315,916, worse than budget by \$180k. The single most significant contributor to the budget variance remains the lack of filming income (2023 filming income budget was \$200k). Operating expenses are also running over-budget by \$42,920. Buildings & Grounds expenses, specifically, are higher than budget due to some plumbing, HVAC, and rectory repairs, electricity expense, increased paper product and cleaning supply usage, etc.
- C In the context of the deficit budget being considered for 2024, a comparison of 2023 personnel cost vs. 2022 is interesting. The addition of approximately \$300k in year-to-date personnel cost in 2023 (as compared to 2022) reflects the adding back of staff positions that were eliminated in 2021. Multiple hires were made during 2022. The only staff position added in 2023 was one additional Buildings & Grounds staff position, which serves to replace/reduce contracted labor.
- D Although substantial funds are being spent each month on the long-term maintenance project (as previously authorized by Vestry), we continue to have more than sufficient assets in cash. A Certificate of Deposit held throughout the past couple of years matures in December and will not be renewed. Following this year-end we will be prepared to re-balance the cash and investment positions. To that end, money will be drawn from the quasi-endowment investments to cure the negative cash position in Fund 4. Other funds currently held in cash may be invested.
- E Since financial reporting was caught up this fall, we continue to improve on financial reporting each month. In November, substantial reclassifications were made to more clearly report the status of the long-term maintenance spending. When bequest income is determined to be undesignated, it is transfered to quasi-endowment per policy. However, because of the \$3.1 mil encumbered for the maintenance project, bequest funds will be passed through quasi-endowment and to the new Long Term Maintenance Fund. Undesignated bequests serve to reduce the amount of money needed from the New Building (Capital Campaign) Fund. Finally, to clarify that \$300k of the Drummond bequest was previously designated for "Liturgical Equipment," a new fund has been formed for that purpose and the balance transferred from quasi-endowment. While seemingly complicated at this time, the reclassifications made in November will provide for clearer reporting as we proceed into 2024.
