

NOTES & HIGHLIGHTS

- A The Net Operating Loss for August was \$81k and exactly in line with budget. Both operating income and operating expenses were under budget by about \$30k during the month. On the income side, August is the month we had projected a fundraising event. That event has been postponed to April 2026 and a smaller event scheduled for later this fall. On the expense side, the personnel line is underbudget for two reasons: (1) several staff took vacations in August and thus were compensated out of the accrued vacation liability, and (2) we are beginning to see the impact of delaying the addition of new clergy.
- B A major component of the Justice and Organizing expense budget is attributable to Safe Haven. Be reminded that while we have a balance in the Safe Haven designated fund, those expenses are being offset through transfers from that fund.
- C Administration expense was over-budget in August because we were charged an additional workers comp premium following the audit of 2024-25 wages. Facilities expenses were over-budget in August due to elevator and fire safety system repairs.
- D Please note that while we are reporting cash in banks at August 31st at over \$8 million, the majority of the reported cash balance is held in money market funds earning 4.2%. The proceeds from the Woodland Rectory sale in June, and recent additions to quasi-endowment are in the process of being moved to our Investment funds at Episcopal Church Foundation.
- E Activity in the Long Term Maintenance Fund reflects continued work on the electrical project approved by Vestry in recent months. No expenses have yet been incurred on the roofing project.
- F Although it is not required to report the principal and accumulated earnings on non-endowed funds separately, we are electing to do so now on the Rectory Investment Fund (previously called the Mission Investment Fund, also known as the proceeds from the Woodland Rectory sale) to maintain transparency about its use. It may be worthwhile to do so until the new rector is called and more is known about how much of the principal will be needed for that purpose.
- G Development/Finance staff and leadership continue to research the foundation for our designated, restricted, and endowed funds. As Vestry requested late in 2024, we are re-establishing documentation supporting these balances and their classification. To that end, a fund has been added to the Investment/Endowment Funds to properly reflect the church's irrevocable beneficial interest in the Leslie E. Learned Trust (established in 1929). Up until now, the financial statements have only reflected distributions from this fund upon receipt as income to the Webb Fund, which is restricted for pastoral needs. Going forward the changes in value of the fund will be recorded as increases to the balance in Investments/Endowments and distributions from the fund will be treated as transfers (like endowment draws). This change has been made effective January 1, 2023 so that the fund will be properly reflected in forthcoming audits of 2023 and beyond. This change has no direct operating impact.
